**TREASURER:** The District 7 office financial report was in all mail boxes. There were no questions.

**RECREATION:** No Report

**STATE CUP:** The draw for the younger age group will be held on November 14 at the CYSA Office. The application dates are the same as Assoc. Cup. If your entry is submitted by October 15, fee is \$575. If submitted by November 2, fee is \$625. If you want to submit your team in the pool, the fee is \$675. but if not drawn, you lose \$100.

**ASSOCIATION CUP:** The fee for entry by Oct. 15 is \$450. If submitted before Nov. 2, fee is \$500. Livermore is hosting the U-10 group on December 5/6, 2009. Draw will be held in Pleasanton on Nov. 15. Richard will contact John to see about hosting an age group.
